#### August was a busy month for city museum

For a smaller museum although, one that is always growing, in one way or another - the Hamtramck Historical Museum (HHM) is one busy institution.

Take the week of Aug. 13 through Aug. 16. A normally sleepy time for many, as people were off traveling, enjoying their cabins, shopping madly for the kids' back-to-school stuff, or watching the Tigers in a pennant chase.

But the HHM was busier than you'd guess.

On Aug. 13, museum representatives down on the Detroit Riverfront at The Icon building, taking part in the first day of the Teaching Diverse Histories Sum-

They had a table set up there, with some information about the museum, and even a few artifacts along for the ride. There was said to be a lot of interest in the museum, especially for the tours that the museum helps arrange.

The next day, on Aug. 14, the museum took part in Day 3 of the summit, where Boardmember Joe Strazalka co-presented - alongside David Hales of the Historical Society - on the topics of partnering for Michigan History Day: how it functions and how it impacts a museum like HHM.

The following day saw museum staffers head over to a professional development session at Dickinson West Elementary School, on an invite from Hamtramck Public Schools (HPS). There, a presentation was made on the city's history, then museum staff took some questions and met one-to-one with a few of the school's teachers.

One teacher suggested a presentation on the city's African-American history, which got the museum reps to thinking about putting one together.

Saturday, Aug. 16 was a Clean-Up Day at the museum. Though turnout was small, perhaps

## Federal court puts an end to lawsuit over pride flag

Hamtramck's pride flag dispute has been settled at least, legally.

This week, Federal Court Judge David M. Lawson dismissed a lawsuit, filed by two former members of the Hamtramck Human Relations Commission, who were seeking to overturn the city's ban on displaying a pride flag on public property.

In the 12-page opinion, the judge basically ruled that the city has the right to control what flags are displayed.

City Attorney Odey Meroueh said the ruling "confirms that Hamtramck has the right to decide what it communicates on its own property."

He added: "The Court's decision vindicates Mayor Amer Ghalib and the City Council for adopting a neutral policy that treats every group and every viewpoint the same. ... This case was about neutral rules, fair enforcement, and responsible city governance, not about suppressing anyone's speech."

Former Human Relations Chairman Russ Gordon could not be reached for comment.

Gordon and fellow compoole defied a city council resolution banning the display of pride flags by raising one on one of the Jos. Campau flagpoles, which are city property.

They were then fired from their non-paid volunteer roles on the commission.

Stackpoole said that, while the lawsuit is over, the debate will continue.

"Disappointed and sad that the court refused to see the underlying motive

was religion," Stackpoole said." The case may be over in the court but not over in the court of public opinion."

The all-male and all-Muslim city council and mayor took issue with the pride flag display because it offended some in the community, claiming the flag promoted homosexuality.

The pride flag represents gay pride.

The flag had been flown in Zussman Park during Pride Month in June, and also on one Jos. Campau flagpole for two years prior to the ban.

The city council and missioner Catrina Stack- mayor, in response to vice on council in this No-Hamtramck's conservative community, took an official action against the pride flag in a resolution passed in 2022, which stated, in part, that the ban was an

act of showing "neutrality." Hamtramck's council resolution allows only the American, state, city and Prisoner of War flags, as well as the flags that represent the international character of the city's residents - many of whom are immigrants, or sons and daughters of immigrants, from various countries in the world.

The ban on pride flags prompted a protest in Zussman Park, across from city hall, where the state's top law enforcer, Michigan Attorney General Dana Nessel, spoke out in protest.

Nessel, who is gay, called the ban a "national embarrassment."

During a three-hour council meeting that led to the pride flag ban, then-city-councilmember Nayeem Choudhury, who is seeking to return to servember's election, didn't hide that the resolution was based, in part, on re-

ligion. "...We have to respect the religions. We have to respect the people around here. Schools, mosques, churches," Choudhury said.

Choudhury also said that the LGBTQ community, which the pride flags represent, is welcomed in other ways.

### Police chief is officially fired

Back in May of 2024, Hamtramck welcomed with open arms and much fanfare - the hiring of Police Chief Jamiel Altaheri.

He came here after retiring from the New York Police Department, having served over 20 years the-

Altaheri was the first Yemeni-American to be appointed to the position, and also one of the few outsiders hired as police chief. Most of those who have served as police chief rose through the ranks of the Hamtramck Police Department – and, in fact, outsiders were generally met with suspicion and resentment.

But things had greatly changed in the department, with many new, fresh faces without family connections to the department.

Altaheri was sworn into office in an outside ceremony, held across from city hall in Zussman Park.

Many Yemeni-Americans from here and Dearborn attended the ceremony, where Altaheri was given a rock-star welcome. In the year-plus that he served. Altaheri initiated a number of community outreach programs, earning him widesp-

read praise. Flash forward to recent months, and Altaheri finds himself fired from the position by the very people who initially championed his hiring: the mayor and city council.

The Review reached out to Altaheri for comment, but he did not respond.

During his brief tenure here, Chief Altaheri oversaw an infusion of racially and ethnically diverse hirings, including women, into the department.

Altaheri also began a series of podcast interviews, called "The Chief's Corner," with local residents and business owners, that aired on social media.

And he was praised for starting a youth police academy here.

The chief's downfall, after an internal investigation that included secretly-made recordings, revealed someone with an apparent dual personality, with one side making the department more community-oriented, and another that dealt in a number of alleged wrongdoings some that may border on criminal.

According to an internal investigation conducted by the law firm Miller Johnson, the following accu-

"Usama was featured on America's Got Talent (2020), selected as a New Face at Just For Laughs (2018), and is a regular at the world-famous Comedy Cellar. His TV debut was on BET's 50 Central, with other appearances on Desus & Mero, MTV News, and Cash Cab.

"He's won numerous comedy festivals, including the Laughing Devil Cup (2016), Yonkers Comedy Festival (2015), and Make Me Laugh Albany (2015), and was a finalist in both the NBC Standup and New York's Funniest competitions in 2017. The Review: Are there any subjects you won't take a shot at, or is it pretty much all fair game for you?

Siddiquee: Never! It's all fair game, just make it funny and come with good energy. If you (don't), it'll show in the bit.

The Review: How, being focused in New York, did you get hooked up with **Progress Michigan?** 

Siddiquee: People know people who know people.

The Review: Will you do any other shows while you are in the area?

Siddiquee: No, just this one. Come out, people!

The Review: Given our large Bangladeshi community here in Hamtramck, might you have any contacts or connections here?

Siddiquee: My dad probably knows every single Bangladeshi in the area, and will tell me to go to their houses for food after the show, one by one.

The Review: Please add anything else you'd like to, including any final thoughts about life, love or the pursuit of the almighty laugh...

Siddiquee: Stand-up comedy is the most fun I've ever had in my life, and I'm truly blessed that people are coming out for the show. It's a genuinely beautiful thing.

That being said: Uncles and aunties, don't be weird in the crowd. Come to laugh! I might joke about some topics you might not agree with; just enjoy it! LOL.

Two dead in housing project shooting,

reports, it appears the shooting was the result of a domestic issue. A man reportedly shot a woman, and then turned the gun on himself.

Social media is reporting that the woman is Brianna Frame, 24, who was shot by an ex-partner, who is the father of their 10-monthold daughter.

There is an online fundraiser for the daughter on GoFundMe, search for "Support Brianna's Family After Tragic Loss."

The housing project has long been the scene of any number of police calls responding to fights, domestic assaults, break-ins and rowdy behavior.

Last week was no exception, as the department responded to a number of calls from households

Some elderly residents who live there told The Review that fights and assaults happen frequently, and that a number of young people feel like they have no future ahead of them.

"All they care about is marijuana," said one resident, who asked not to be identified. "They feel that they have no future."

The previous shooting incident at the projects happened back in May, when a teen shot two other teens, both of whom managed to survive.

It was said that the shooter shot the two after being beaten up by one of them.

And in the breaking news department, Hamtramck police announced the arrest of two armed robbery suspects.

Here's the statement the police department issued:

"On Sept. 9, an armed robbery occurred in the area of Casmere and McDougall at approximately 6:30 p.m. Within two hours of the crime, Hamtramck Police arrested two juveniles in connection with the armed robbery. During the arrest, property belonging to the victims and a handgun were recovered from the suspects.

"The juveniles were transferred to the Wayne County Juvenile Detention Center pending prosecution. The Detective Bureau is investigating to determine if the duo may be involved in any other crimes in our city."

#### evidence Destroying and obstructing the investigation

When Altaheri was placed on administrative leave by Garbarino, one of Altaheri's first reactions after leaving Garbarino's office was to wipe his City-issued phone. Altaheri directed an evidence technician (and Altaheri's friend) to erase the data on his phone. The technician immediately did so. Altaheri's directive to destroy evidence violated multiple City policies.

#### **Driving his City-issued** vehicle after consuming alcohol

The investigation substantiated a widely known instance of Altaheri driving recklessly in his City-issued truck after consuming alcohol.

The evidence established that, on September 19, 2024, after attending an officer appreciation party and consuming alcohol, Altaheri drove to and from a strip club, with other officers riding with him, in his City-issued truck.

He activated his police lights to run red lights and drove erratically. Multiple witnesses observed him consuming significant amounts of alcohol and/ or appearing inebriated before driving that night. Multiple officers also witnessed him driving recklessly.

Videos of his driving taken that night confirm their account, including showing Altaheri activating his police lights to run a red light and then immediately turning off his lights after he drove through the intersection with no plausible legitimate justification.

In addition to this significant incident, the investigation revealed other likely instances in which Altaheri consumed alcohol before driving his City-issued truck.

#### Reducing another officer's discipline in exchange for the destruction of evidence

The video of Altaheri's reckless driving also gave rise to another violation of HPD's rules and regulations. A few months after the reckless driving incident, it was discovered that an HPD officer had committed timecard fraud. The officer, however, had a copy of the reckless driving video.

During the officer's recorded disciplinary hearing, the officer should have been terminated or forced to resign in lieu of termination for timecard fraud, and Altaheri concluded as much.

However, prior to the hearing's conclusion, Altaheri and the other officers involved in the disciplinary proceeding went off the record and met in a hallway to discuss the officer's corrective action further. During that hal-Iway conversation, Altaheri agreed to a lesser penalty in exchange for the officer deleting the reckless driving video.

Altaheri then came back on the record and changed the resignation in lieu of termination (as previously negotiated) to a 30-day suspension.

Because the evidence demonstrated that Altaheri's decision to reduce the severity of the discipline was influenced by his desire for the officer to destroy compromising evidence against him, Altaheri's conduct violated HPD's rules and regula-

#### Handing a loaded gun to a civilian and instructing her to put it to someone's head

The evidence also substantiated the allegation that Altaheri handed a loaded gun to a civilian volunteer and told her to put it to someone's head.

A recording of that incident was previously released publicly, and is now the subject of local news articles. An officer who witnessed the event - and who quickly took the gun away from the volunteer - confirmed that the recording was accurate and

Issued by Hamtramck Public Schools on behalf of the Stronger Connections Consortium

Hamtramck Public Schools is accepting proposals from qualified video production companies to develop and execute a multi-video campaign focused on improving K-12 student attendance throughout Wayne County. This project is funded by the Stronger Connections Grant and seeks to address the urgent issue of chronic absenteeism, which currently affects approximately 43% of students across the county.

The goal of the campaign is to produce a series of high-quality, short-form videos that will promote consistent school attendance in a positive, culturally responsive, and community-driven way.

not Altaheri was "joking," as he has claimed, the evidence shows that he created a serious danger in handing a loaded firearm to an untrained civilian volunteer in a crowded room.

Further, Altaheri's contention that the firearm was unloaded is implausible given the available evidence, and even handing an unloaded gun to the civilian in that setting would violate HPD po-

#### Pressuring officers to help him in a custody dispute

At least five 911 calls prompted HPD officers to respond to the residence that Altaheri shared with the mother of his two-year-old son.

There is evidence reflecting that in one instance, Altaheri suggested that officers conduct an investigation at the residence in a way that would be favorable to his position in a dispute over custody of his son.

On September 19, 2024 (the same night as the driving incident described above), officers responded to the house following a 911 hang-up call on which Altaheri and the woman can be heard arguing. Altaheri then apparently left the residence and arrived back at the house, giving the appearance that he was not at home when the 911 call was placed.

The police observed that the woman's foot was injured, and the officers treated the call like a medical incident. Altaheri, however, told the officers to investigate her for drug use, conveying to three of them that he was hoping to use what they found (and any resulting police report) to gain custody of his son.

them believed there was a basis to investigate her for drug activity. Altaheri then told one of the officers to write the police report in a way that would be as vague as possible while helping him build his custody case.

The police report described the woman's eyes as "glossy, bloodshot, and ... not to react to light," while omitting any mention of the incident.

#### stolen property

The investigation substantiated that Altaheri participated in the recovery of a vehicle that had been reported as stolen without following standard police practices and procedures. The vehicle, an expensive Mercedes Benz, was in the possession of one of Altaheri's acquaintances.

Altaheri persuaded the acquaintance to turn over the car voluntarily to one of Altaheri's longtime friends from New York. Adamczyk and two civilians - one a convicted felon - participated in the effort to recover the car and transport it to New York.

Although there were differing accounts as to whose idea this escapade was, with Altaheri and Adamczyk pointing fingers at each other, it is undisputed that both of them participated in the conduct and failed to follow basic police procedures governing the recovery of a stolen car.

### **Violating other policies**

and procedures The evidence obtained during the investigation also revealed that Altaheri gave Adamczyk unfettered access to his electronic signature and to at least one of his City-issued email accounts in violation of HPD policies. Altaheri's conduct during two meetings in May 2025, one of which was recorded, also included physical and verbal threats that violated HPD's rules


