Recently, Sabree announced a mobile office you can go to without the hassle of finding parking downtown.

"The new mobile unit will provide Wavne County residents easier access to taxpayer services year-round, by traveling to communities across Wayne County and making it more convenient for property owners to pay their taxes and enroll taxpayer-assistance programs designed to help properties owners with financial challenges in this tough economy," said Sabree in a press release. "The new mobile office can provide county property tax services and information to people right in their own communities."

The mobile office will travel county-wide to community centers and local events, so that Taxpayer Assistance teams can provide services to local residents close to home.

"Our goal is to make Wayne County Treasurer's services and information easily available, and the new mobile office is another way we can help Wayne County residents keep their properties and stay in their homes." said Sabree.

Three join election as write-ins

The upcoming Nov. 4 city election just got a whole lot more interesting.

Two city council candidates who didn't make the final cut in the August Primary Election, Joe Strzalka and Diane Elizabeth Frkan, are running write-in campaigns to give it one more shot.

Also, former city council candidate Lynn Blasey, who failed to win a seat on council two times in other years, is now seeking the top job as mayor, also as a write-in candidate.

Strzalka, who is a former councilmember and now retired from the U.S. State Department, said he is getting feedback from some voters that they were going to write his name in anyway.

That would not have counted, because candidates have to register as a write-in in order for the votes to be legitimate.

So, with that in mind, Strzalka said he was "honored" - and filed.

"In some ways, it's a protest vote," Strzalka said.

continued: Strzalka "There are many people who feel there were irregularities in the primary, and they have no legitimate candidate to vote for. This way, people can still vote in the general election without voting for a person believed to have committed election fraud."

Although write-in candidates are usually considered longshots, it does sometimes work. Detroit Mayor Mike Duggan is a prime example of running as a successful write-in candidate, as he did for his first term.

Frkan, who was the only woman on the August ballot, told The Review that the reason she is running again is "because our community deserves a stronger, independent leadership that puts its residents first. I refuse to sit back, when I know that I can contribute to posi-

At Dickinson East Elementary, a sewage odor raises a stink

A mysterious foul odor wafted through Dickinson East Elementary School last week, that raised health concerns and questions about the school district's response.

A teacher at the school, who asked not to be named for fear of reprisal, brought media attention last week over a sewer stench that caused a number of teachers and students to complain.

According to teacher, going to the media was a last resort, after being frustrated that no one from the district office took timely action to remedy the issue.

According to a Channel 2 Fox News report, district Interim Superintendent James Larson-Shidler said that the odor

came from a malfunctioning sump pump in the school's boiler room, but that it was only tempo-

Larson-Shidler told the news station that the problem had been taken care of, and that repair crews acted on the matter promptly.

On Monday of this week, the teacher told The Review that, while the odor had largely been abated, it still lingered.

"The smell is not as bad," the teacher said. "It's to the point where we can actually work in the office."

But the teacher said this issue highlighted more than just a problem with the building, it also illustrated a "lack of transparency" from the administration.

"They told us we were making a big deal out of a small issue. We weren't taken seriously" the teacher told The Review. "They haven't been transparent with the staff or the parents."

The Review reached out to Larson-Shidler, who said that, as of Monday of this week, "No odor issues were observed at that time."

He also said that the original problem was caused by heavy rains that created a high water level in the sewer system next to the school. That led to a failure in being able to pump all the water out.

Shidler said the sump pump is now working.

In another matter, at the Sept. 10 school board meeting, a parent complained that there are no nearby restrooms for the special education students who are taught in the basement.

The parent said students have to go up a flight of stairs to use the nearest restrooms.

Also, another parent complained about the smoke bombs that are deployed at soccer games by the Detroit City Football Club in Keyworth Stadium. He said the

smoke is "suffocating" the neighborhood next to the stadium.

"We have kids around the blocks who have asthma." Shukri Kassim said. "Two kids ended up in the hospital because of that last month. We are asking for cooperation from you guys before this season ends so we can start smoothly next season, otherwise it's going to escalate."

Kassim said attornevs have been contacted to take action against the district.

School board members did not respond because it is the board's policy to refer all questions and concerns to the appropriate department.

In the past, residents have complained that there is no follow-up from the district on matters that are brought up at board meetings.

And that would be a recipe for another state takeover, unless some critical and unpopular financial decisions are made. Either we do it ourselves, or someone appointed by the state will come here to make those decisions.

For Fire Prevention Week, follow battery safety guidelines

The theme for Fire Prevention Week, Oct. 5–11, is "Charge into Fire Safety: Lithium-Ion Batteries in Your Home."

The Hamtramck Fire Department is teaming up with the National Fire Protection Association (NFPA) — the official sponsor of Fire Preven-



tion Week (FPW) for more than 100 years — to promote this year's FPW campaign, "Charge into Fire Safety: Lithium-Ion Batteries in Your Home." It highlights how important it is to buy, charge, and recycle lithium-ion batteries safely.

Most of the electronics we use in our homes every day — smartphones, tablets, power and lawn tools, laptops, e-cigarettes. headphones, and toys, to name just a few — are powered by lithium-ion batteries. In fact, most everything that's rechargeable uses

this type of battery. If not used correctly or if damaged, lithium-ion batteries can overheat, start a fire, or even explode. To reduce these risks, look around your home — it's important to know which devices are powered by them. Lithium-ion batteries are powerful, convenient, and they're just about everywhere.

This year's Fire Prevention Week campaign helps people understand the importance of using these batteries correctly to prevent fires in the

home and to follow the Buy, Charge, and Recycle Safely approach."

Buy only listed products.

· When buying a product that uses a lithiumion battery, take time to research it. Look for a stamp from a nationally recognized testing lab on the packaging and product, which means that it meets important safety standards.

 Many products sold online and in stores may not meet safety standards and could increase the risk of fire.

Charge devices safely.

- · Always use the cords that came with the product to charge it. Follow the instructions from the manufacturer.
- If you need a new charger, buy one from the manufacturer or one that the manufacturer has approved.
- Charge your device on a hard surface. Don't charge it under a pillow, on a bed, or on a couch. This could cause a fire.
- Don't overcharge your device. Unplug it or remove the battery when it's fully charged.

Altaheri was recently fired by the city council over various allegations of wrongdoing.

Protesting ... The Detroit News recently published a story on the growing frustration in the Yemeni community over President Trump's reinstated travel ban on Yemen.

Obviously, this has frustrated and angered a number of folks in the Yemeni community, and has had a ripple effect among a number of families.

U.S. Rep. Rashida Tlaib (D-Detroit) was quoted in the paper as saying the ban is really about "profiling and targeting certain people based on their ethnicity and their faith and the color of their skin."

In Hamtramck, which has a sizeable Yemeni population, not much has been said about the travel ban, and, with Mayor Amer Ghalib aligned with the Trump administration, it's doubtful there will be

Word is out ... There are certain people going around town pressuring some businesses to stop advertising with The Review, including a certain independent journalist (no, it's not "Sunglasses Man" as some call him).

Trial begins ... The two suspects charged with killing a beloved Hamtramck businessman in a home robbery are now undergoing a trial for their alleged crime.

Joshua Zuazo and Carlos Jose Hernandez are accused of killing Hamtramck businessman Hussein Murray, 72, in his Rochester Hills home.

Hernandez, 37, and Zuazo, 39, are charged with felony murder and two counts of unlawful imprisonment.

It's a bizarre story, wherein they are accused of posing as utility workers who lied about a gas leak to get inside the house, where they thought they could steal money, or gold, or anything of value.

Instead, they ended up allegedly killing Hussein, and tying up his wife with duct tape.

This incident happened in October of 2024 – a year ago, now.

Experience counts ... Michigan ranks seventh in the country for having the most experienced teachers, according to a new survey.

People with Radius.ac, an artificial intelligence generator, analyzed data from the most recent National Teacher and Principal Survey to determine which states have the most experienced K-12

Michigan came in Number 7 (really, Number 8, as two were tied for fifth, and they count funny).

Behind only Rhode Island, Maine, New Hampshire, Ohio, a tie between Connecticut and Pennsylvania, and Nebraska, Michigan teachers averaged 15.4 years on the job.

That puts the state at 6.21 percent above the national average, with 53.8 percent of our teachers having 15 or more years' experience.

Contrast that with Number 1 Rhode Island, whose teachers average 16.9 years, or Number 50 Utah, at an average of 12.1 years.

The five states with the least experienced teachers on average were Utah, Mississippi, Arizona, North Dakota and Idaho.

... For those fresh out of high school who are trying to figure out a career, the state has a deal for you.

And for many, it comes with a generous financial helping hand.

The Michigan Department of Lifelong Education, Advancement, and Potential (MiLEAP) and the Michigan College Access Network (MCAN) are encouraging students to take the first steps toward their futures, by submit-

ting college applications

and exploring postsecondary opportunities.

MiLEAP was established by Gov. Whitmer about two years ago, in 2023. MiLEAP offers a multitude of programs to help students access affordable pathways to earn a degree or skill certificate after high school.

MCAN's work centers on one main goal: To increase Michigan's post-secondary education attainment.

Some quick, and encouraging, facts:

- 7 in 10 students are eligible to receive up to \$27,500 to attend a Michigan college or university through the Michigan Achievement Scholarship.
- · All students are eligible for a tuition-free or low-cost pathway through the Community College Guarantee, allowing them to earn a skill certificate, associate degree or to start taking classes toward a bachelor's degree at a Michigan community or tribal college.
- All students are eligible for up to \$4,000 up to \$2,000 per year for two years through the Michigan Achievement Skills Scholarship, to earn an industry-recognized certificate at a qualifying career training program.
- Michigan Reconnect also supports adults ages 25 and older to earn a tuition-free associate degree or skill certificate at their local community college.

"We want students to know it's not too early for them to start planning their futures, and that we're here for them when they do," said Sarah Szurpicki, deputy director of MiLEAP's Office of Higher Education.

"Applying to college or career training now is the first step, and completing the FAFSA when it opens this fall will be the next."

State Republicans want to make a deep financial cut to city

Hamtramck may take a heavy financial hit if state Republicans are successful in passing a new state budget.

State Sen. Stephanie Chang (D-Hamtramck), whose district includes Hamtramck, sent out a social media blast on Facebook saying that communities should brace for "massive cuts to revenue sharing" for communities statewide.

For Hamtramck, the financial hit would be \$2.5 million, which is the second largest cut for communities in her district. Hamtramck's annual budget is about \$20 million.

The city is already facing a yearly financial loss of \$1.4 million from the operation of a Wayne County jail located here. That jail is no longer operating as a jail.

The heaviest financial blow would come to Detroit, at \$23 million less per year.

Following Hamtramck in third place for a financial loss is Warren – the third largest city in the state – with a population of over 137,000, which dwarfs Hamtramck's population of 24,424.

Hamtramck Interim City Manager Syed Aamir Ahsan told The Review he was unaware of the proposed budget cut, but said that, if it does get approved, the city "would have some serious consequences."

But, he cautioned that as of now, "I think it's just a discussion."

However, Chang advised residents on social media:

On social media, Hamtramck residents weighed

in on the proposed cuts.

"Hamtramck is one of the poorest cities in the state. This is terrible," said Joni Sobczak. And Hamtramck Public

And Hamtramck Public School Board member Linda (Stachowicz) Wolyniec has this question for city officials:

"(Mayor) Amer Ghalib, (Councilmember and mayoral candidate) Muhith Mahmood, (mayoral candidate) Adam Alharbi can any of you as the current and potential mayor please tell us what is being cut and how it will affect the City of Hamtramck?"

Mayor Ghalib took issue with Chang's interpretation of the proposed budget cuts, saying it isn't "accurate."

"I can confirm that we received more money this year than last year, and that our budget is stable despite losing the jail revenue, and I'll announce details about it soon," Ghalib said.

"I'm happy with the current state of the city, and hopefully there would be some good surprises for our residents before the end of the year."

Ghalib's sunny financial forecast, however, is in direct conflict with a recent assessment by the accounting firm Plant Moran, which is predicting the city is in increased deficit spending — meaning the city is spending more

money that it is receiving.

Ghalib did say, at a recent city council meeting, that he has met with White House officials to discuss possible financial aid to the city that could result in millions of dollars being poured into the city.

He has not offered any specifics on what that would entail.

The Review also reached out to mayoral candidates Muhith Mahmood and Adam Alharbi via their Facebook messaging for comment, but they did not reply.

What is our City Council up to these days? We have the highlights of the latest council meeting.

The city council met on Sept. 9, and all councilmembers were in attendance except for Khalil Refai and Muhith Mahmood. Mayor Amer Ghalib was also absent.

City Attorney Odey Meroueh announced that Councilmember Refai submitted a letter informing the city that he is stepping down from his position of Mayor Pro Tem.

The first order of business was for councilmembers to appoint a colleague as the new Mayor Pro Tem. Councilmembers unanimously supported Councilmember Abu Musa to the po-

Next up, the Executive Director of the Hamtramck Parks Conservancy, Tom Habitz, said that a "Family Game Night" will be held on Sept. 30 in the newly paved Goodson St. alley that runs next to Veterans Park.

proclamation was

read, thanking the volunteers of the Hamtramck Labor Day Festival.

It said, in part:

"... In recent years, the Labor Day Festival has been thoughtfully organized and successfully carried out under the leadership of Konrad Maziarz and Shannon Lowell, along with a dedicated team of volunteers, whose tireless work, creativity, and commitment have ensured its continued success, and the Festival provides invaluable opportunities for local businesses, community organizations, artists, and performers to share their contributions and highlight the unique spirit of Hamtramck.

"And, the event not only enhances the city's vibrancy cultural but also fosters civic pride, strengthens community bonds, and supports local economic vitality."

During public comment, Shaker Sakead spoke about the pending election fraud allegations and other election allega-

"I have been in this city's politics for a long time," Sakead said. "Some of our city officials have used the law enforcement of the City of Hamtramck and media to be weaponized against the citizens, and the vote fraud thing has become a joke."

Sakead complained that police investigators have been knocking on residents' doors to inquire about election issues. but they fail to tell the people being interviewed that they don't have to say anything.

He said the investigations have intimidated voters, which will possibly cause some to not vote.

Sakead asked for an independent investigation into the matter.

"People have been misguided," he said.

He also accused authorities of unfairly focusing on Councilmember Mohammed Hassan, who has been charged, along with Councilmember Muhtasin Sadman, of various election law violations stemming from the 2023 election.

Investigators, Sakead said, have an "agenda" "to take Hassan down, and I've been part of it."

Back in January, the state Attorney General's Office sought warrants for Hassan and Sadman, as well as for Sakead.

At the time, the state alleged Sakead of the following: Impersonating another (person) to vote at an election, absentee ballot tampering, and inducing an unqualified voter to apply for an absentee ballot.

Ultimately, no charges were ever filed against Sakead.

The council OK'd another step for the city to become a part of the state's Michigan Main Street Program.

The program would allow the city to "gain access to a range of resources, including design and business assistance, support. organizational and promotional strategies."

The council also OK'd renewing its liability and property insurance policy through the Michigan Municipal Risk Management Authority.

Interim City Manager Syed Aamir Ahsan said there is a 3 percent increase from last year in cost, but it's also about half of what the city paid two years ago.

The cost for the policy is about \$400,000. Ashan said the slight increase is due to increased property values.

In the segment for councilmembers to comment. Councilmember Musa praised Mayor Ghalib.

"Our beloved mayor is in Washington, D.C. ... I wish him very, very good luck, and don't forget us. Bring some special funding for the City of Hamtramck," Musa said.

Councilmember Hassan spoke about the ongoing election investigation and

the charges he faces.

"The truth will come out very soon," Hassan said. "Please be patient and pay attention to what you speak, what you do. Don't listen to the people and make the comment on what maybe is not truth."

Regarding the mayor's President effort with Trump's administration to channel funding to Hamtramck, Hassan said "he is still working very hard in the White House. Try to get some fund for Hamtramck city. Hopefully we're going to get it and we'll work together make a better one Hamtramck."

As for accusations of

corruption in the city, Hassan again said "the truth will come out who is the corrupted, where is the corruption. I don't have to speak. Please be patient."

Hassan closed with a request on an update on city finances, such as the revenue coming in and the city's expenses and retirement costs.

"People have a right to know where we stand," Hassan said.

Councilmember Mohammed Alsomiri said "Hamtramck stand for years and years. It's not going to be
