On 05/11/2020 at approximately 1325 hours, PO Smith #37 and I, PO Golla #41 (SCT 3) were dispatched to 11325 Joseph Campau RE: PDA / PIA. While en route, Dispatch advised us that one of the units involved in the traffic crash is a Detroit Police Patrol vehicle (See crash report 20-2982).

SGT. Cornwell #82 and SGT. Mervyn assisted on scene.

Upon arrival, Officers made contact with the driver of Unit #2 (██████████ / victim) who stated while he was traveling W/B Caniff at Joseph Campau, Unit#1 disobeyed the red light and struck him. ██████████ stated that the traffic light was green for him. ██████████ also complained of ██████████

Officers made contact with the driver of Unit #1 (██████████ / arrestee) in front of 11300 Joseph Campau (PNC Bank/by the drive up/ATM). ██████████ was detained by a Detroit Police Officer due to attempting to leave the scene of the accident. ██████████ appeared to be disoriented from the traffic crash and was unable to state what happened during the incident. Officers advised ██████████ that he was the register owner of Unit #1 vehicle at which time ██████████ stated that he was the driver.
