Caniff repaving project is now underway – prepare to complain

Get ready for a summer of doing the Caniff dodge.

Last week, construction began on Caniff, starting at the I-75 service drive, and it's likely going to take pretty much the entire summer for the street to be repaved up to Jos. Campau.

The eastbound lane of the street is, at times, open for traffic. The repaving will be done one side at a time. When the westbound side is completed, it will be opened and the eastbound side will be closed.

The city is calling for patience.

"In the end, we'll have a new street," said Mayor Karen Majewski during her weekly Monday Facebook update on the ongoing COVID-19 crisis.

street was repaved from Lumpkin to Conant.

Businesses along that stretch of the street all suffered, and residents were forced to cut through alleys to leave home and return. Expect the same thing to happen to businesses and residents

Not only is there a new

street coming, but also lead water lines will be replaced for homes and commercial buildings. Notices were delivered to residences and businesses informing owners, informing them that they must sign off on allowing the city to replace their water lines.

The project is largely

being funded by a \$1.4 million federal grant. The city has to kick in about \$300,000 from its annual state-funded road sign repair grant.

At the same time, the county will be repaving Conant through Holbrook. So far, final plans for creating a bicycle lane on

There has been much talk in town the past couple of weeks regarding the street harassment of women.

It's a problem that has plagued women in Hamtramck for decades - which ranges from catcalls to aggressive sexual propositions.

Recently, a local reporter, Simon Albaugh, inquired about the issue on social media resulted

However, several women advised against this resolution, fearing that any new law might end up giving officers the green light to single out minorities and harass them.

A bare majority of the council agreed to postpone voting on the resolution to further explore it – much to the objection of Perrotta. (Councilmember Saad Almasmari also sided with Perrotta, and voted against the postponement.)

As it turns out, there are a number of state laws on the books that cover the subject.

We searched several online sites that addressed issue, and found one in particular, at stopstreetharassment.org, had the most information about Michigan's laws on the subject.

Some of the state's laws seem outdated in their language and how women are viewed. They've been labeled as sexist by some.

There are also laws that prohibit up-skirt photo taking, following a person, indecent exposure and groping.

According the website, there are six Michigan So, what are some of laws that specifically zero

Here are the laws out-

lined by the website: · "Cursing and Swearing §750.103 - Cursing in public is illegal in Michigan. If a street harasser is using foul language or calling you swear words, you can report him/her.

"Note: The law states that a prosecution can only be sustained if it is commenced within 5 days of the incident, so if you intend to report someone for cursing and swearing, you'll want to do so right

"Penalty: Cursing and swearing is a misdemeanor in Michigan, punishable by a fine of up to \$500 and/or up to 90 days in jail."

"Disorderly son§750.167 - Michigan addresses disorderly conduct by defining who is considered a 'disorderly person.'

"The list of 'disorderly persons' includes a range of offenses, but those relevant to street harassment are:

Window peeping.

Engaging in indecent or obscene conduct in a public place.

Being intoxicated in a public place and either endangering the safety of another or causing a public disturbance.

Loitering in or about a place where illegal business is being conducted (this might be someone buying or selling illegal substances, vending on the street without a permit, or soliciting prostitution).

"Penalty: Disorderly conduct is a misdemeanor in Michigan, punishable by a

fine of up to by a fine of up to \$500 and/or up to 90 days in jail."

 "Improper Language in the Presence of Women and Children- §750.337 It is illegal in Michigan to 'use any indecent, immoral, obscene, vulgar or insulting language in the presence or hearing of any woman or child.'

"This law is rather sexist, but it's a law on the books. If you're a woman or a minor and a street harasser is using this kind of language toward you or in your presence - whether cursing, insulting you, or making obscene or vulgar comments - you can report him/her.

"Penalty: Using improper language in the presence of women and children is a misdemeanor, punishable by a fine of up to \$500 and/or up to 90 days in jail."

 Soliciting Prostitution§750.448 - Soliciting, inviting, or accosting

another person to engage in prostitution is illegal in Michigan. If a street harasser solicits sexual activity from you, you can report him/her.

"You can also make the case that harassers who yell, "How much?!" or offer you money, or anything else, for sex, even in jest, are soliciting prostitution.

"Penalty: Throughout Michigan, soliciting prostitution is a misdemeanor, punishable by a fine of up to \$500 and/or up to 93 days in jail."

 "Unlawful Filming/ Photography Surveillance of an Individual Having Reasonable Expectation of Privacy§750.539j - It is illegal in Michigan for a harasser to surveil, photograph, or otherwise record or capture an image, and/ or disseminate or share that image, of you in your underwear, of your underwear, or of your unclad genitalia, butt, or breasts under circumstances in

which you have a reasonable expectation of privacy.

"The Michigan statute doesn't define what the circumstances under which you can reasonably expect privacy are, but those circumstances usually include being in:

Your home or another private place

A dressing room

A locker room

A restroom - It also usually includes the private areas of your body that are covered by clothing.

"If a harasser peeps on you, take an up-skirt or other inappropriate photograph, or records you inappropriately, you can report him/her. Penalty: Surveillance of or photographing or recording an individual having a reasonable expectation of privacy is a felony, punishable by a fine of up to \$5,000 and/ or up to 5 years in prison."



posure Indecent Exposure§750.335a - Michigan law prohibits knowingly making an open or indecent exposure of one's person or the person of another.

"That means it is illegal for anyone to flash or expose him or herself and it is illegal to expose a nonconsenting person's body, for example by lifting up a woman's skirt.

"If someone flashes you or exposes him or herself to you, or exposes you in some way, you can report him/her.

"Penalty: Indecent exposure is a misdemeanor, punishable by a fine of up to \$1,000 and/or up to 1 year in jail. If the harasser was also fondling his or her genitals, pubic area, buttocks, or, if female, breasts at the time of the

incident, the penalty rises to a fine of up to\$2,000 and/or up to 2 years in prison.

(Note: "If you think someone is following you, you can call 911 right away, the first time it happens. You do not have to wait for that person to commit a crime.

"Attempt to Commit Crime§750.92 - Michigan has a provision that holds

any person accountable that attempts to commit a crime, even if s/he doesn't succeed.

"If you are being harassed or followed and you think the harasser may try to commit a crime -such as sexually assaulting you -you can report him or her to the police.

"That person will be held accountable in proportion to the crime s/he intended to commit. This applies whether the person was apprehended in the process or simply fails to complete the crime.

"Penalty: The penalty for attempting to commit a crime is proportional the crime that was attempted. For example, if it is found that a harasser attempted to commit criminal sexual conduct in the fourth degree (groping), the penalty for his or her attempt would be up to half of the penalty for that crime: a fine of up to \$250 and/or up to 1 year in jail."

Once you make a report to the police department, be sure to get a report for your own records.

the object of such conduct or which the person accused has reason to know is likely to produce such reactions, or as any repeated verbal communications which, by its very utterance, inflicts injury or tends to incite an immediate breach of peace."

Also, the city's law addressing disturbing the public peace seems to address the issue of street harassment. It outlaws:

"Persist in disturbing the public peace and quiet by loud or aggressive conduct, having once been clearly informed by persons affected that she or he is, in fact, unreasonably causing such a disturbance, provided, however, that notice need not be given when such persons affected reasonable believe that to do so would constitute a risk to their personal safety."

Jos. Campau are still to be worked out, but lane installation was expected to take place sometime this summer.

Or maybe not. According to one insider familiar with the project, it's getting complicated, in a way that only county bureaucrats can muck things up.

And yes, Jos. Campau is a Wayne County-owned road - just like most of Conant.

Campau between Belmont and Yemans

· Alley 4 - West of Conant between Belmont and Yemans

· Alley 5 - West of Conant between Yemans and Evaline

Also included in this year's alley repair project is the repaving of the parking lot at Caniff and McDougall.

This project is costing the city \$440,000, which is being paid by the city's yearly state-funded road repair grant.

Police reform begins with civilian oversight

Police reform has been on the minds of many folks nationwide following a spate of police shootings of unarmed suspects.

Recently, a Hamtramckbased writer proposed, in an opinion article in modeldmedia.com, abolish the Hamtramck Police Department.

As you would expect, writer Elizabeth Garrett's editorial drew a lot of attention and blowback.

No matter what you think of Garrett's proposal, she did correctly point out Hamtramck's long history of officers being abusive, and costing the city hundreds of thousands of dollars in legal fees and lawsuit

the years.

She incorrectly, however, claimed that Hamtramck has a low rate of crime – especially violent crime.

While Hamtramck is relatively safe, it is an inner city surrounded by some of the poorest neighborhoods in Detroit.

It was just recently that Hamtramck was victimized by armed suspects who were viciously attacking and robbing people on the streets. Good old-fashioned police work led to their arrests.

There has also been increased pressure for officers to crack down on careless and speeding drivers.

Certainly, it's always settlements throughout worth discussing what

we want our police department to do every so often.

To that end, it has been proposed to establish a civilian police commission to tackle the many thorny issues policing raises. For some reason, this never gained traction.

It is a proposal that is long overdue for the city council and administration to tackle.

Residents need a voice - and oversight on what we want our department to do.

We disagree that the solution is to eliminate the department - which, as the old saying goes, is like "throwing out the baby with the bath wa-

New start... As of April 12, Michigan's "Clean Slate" Pilot Program kicked in, allowing many Michiganders the opportunity to expunge old crimes from their records that potential employers might

The law is complex and

would direct those interested in getting the full picture of eligibility - the who, what, when and more – to the Attorney General's office, under the Michigan.gov website.

A press release from Michigan Lt. Governor Garlin Gilchrist's office outlines a further bit of help: the Michigan Dept. of Labor and Economic Opportunity has awarded funds to Michigan Works! agencies, to assist persons seeking work with trying to clean up their legal boo-boos.

In short, if the crime(s) in question meet(s) the criteria for expungement, and the person is granted an order setting aside their conviction(s), they may then legally state (on any job or school application) that they have never been convicted, or arrested, of the crime(s) in question.

Likewise, they may also legally state such on any applications for public benefits, housing or employment.

The Clean Slate program is considered a temporary bridge program until automatic expungements kick in. Those are rumored to begin in a couple of years.

Federal help... Congresswoman Rashida Tlaib, of Michigan's 13th District, announced that her funeral assistance program portion of the American Rescue Plan had kicked in, allowing survivors of COVID-19 victims who died from the disease to petition FEMA for funeral expense funds.

Michigan residents who bore the cost of funeral expenses after January 20 of 2020 (i.e., well over a year ago) for persons who death may have been caused, or was likely the result of, COVID-19, can apply for up to \$9,000 of assistance (per funeral) Mondays through Fridays, 9 a.m. to 9 p.m. Eastern Time through FEMA's call center number: (844)

The purpose of the proposed project is to provide lead service line replacement as required by the Lead and Copper Rule (LCR) in June 2018 requiring all cities in Michigan to replace all lead water service lines. The water service lines must be replaced from the City-owned water mains within the street to 18 inches inside individual houses. The water projects will involve water main replacement in through open cut in one (1) location and pipe bursting of the existing watermain in four (4) locations to upgrade the main in areas and not to disturb large sections of road, this work includes upgrading valves and hydrants in these areas. City of Hamtramck Notice of Ordinance Adoption

Public Hearing was held at the Regular City Council Meeting on April 13, 2021 at 7pm via public Zoom for the purpose of hearing public comments on adding language regarding curb cuts and driveways to the Hamtramck Zoning Ordinance

V – 1.06. Structure and Site Requirements.

- h. No new driveways or curb cuts in residential zones shall be permitted unless authorized by this Ordinance.
 - V-1.06 H (1) A new curb cut for a driveway shall only be allowed on lots with a residential structure.
 - V-1.06 H (2) A new curb cut for a driveway may be approved if the driveway design meets the standards of IX-5.06.
 - V-1.06 H (3) A permit from the Building Department must be approved before construction begins on a new curb cut or driveway.

IX-5.06 Requirements for Residential Driveways

5.06.1 Driveways in the residential district must hold at least 2 vehicles.

5.06.2 Pervious driveway surfaces may be utilized to meet the landscape requirements of V-1.06(i). Acceptable pervious pavements include porous asphalt or concrete and permeable pavers or others approved by the Building Official. Gravel and other loose aggregates are prohibited.




